

# **Coach Code of Conduct 2011**

As a coach, you set an example for the young people who are participating in CYM Volleyball. All coaches are responsible for helping enforce the Code of Conduct and should use the "code" as a guide for their own behavior. The rules state that no practice or competition may occur without competent adult supervision. An adult is a person who is 21 years of age.

As a Coach or Assistant Coach, I understand and agree to the following:

- I will abide by the parish and league rules, Code of Conduct and the directions of officials.
- I will review all parish and league rules with the players on my team.
- I will be responsible for verifying the eligibility of the players on my team and submitting required paperwork for participation.
- I will review and uphold the Player Code of Conduct with my team.
- I will do my best to insure a safe and healthy environment for the young people involved in CYM Sports.
- I will do my best to set a good example for young people to imitate.
- I will refrain from using alcohol or illegal drugs at CYM facilities before, during or after CYM practices or events. I understand that inappropriate behavior of this kind will not be tolerated and I may be barred from future CYM activities.
- I will refrain from using tobacco products in the gym while games are being played.
- I will be responsible for the actions of team members and spectators from the parish encouraging them to conduct themselves in a Christian manner that will reflect positively on their family, parish and CYM Sports.
- I will teach and guide the youth of the team with a sense of fair play, sportsmanship and acceptance of winning and losing in accordance with Christian values.

**Please note: When you sign Team Registration Form, you agree to abide by this Code of Conduct. Violations of the Code of Conduct may result in disciplinary action from the League Oversight Committee.**
